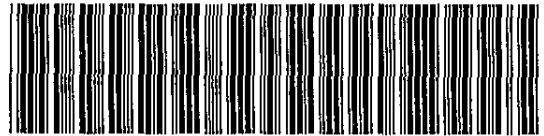

Pursuant to the provisions of Section 608.411, Florida Statutes, the undersigned limited liability company adopts the following Articles of Amendment to Articles of Organization:

1. The name of the limited liability company is MTB Global, L.L.C., N/K/A Pace Weinzierl Enterprises, L.L.C. ("Company").
2. The Articles of Organization of this limited liability company were duly filed with the Florida Department of State on January 21, 2003, and assigned Document Number L03000002260.
3. This limited liability company's Articles of Organization are hereby amended as follows:
