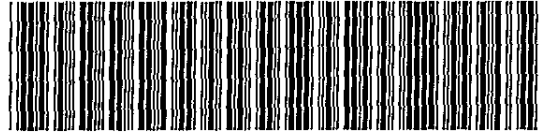

**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION  
OF

THE ARTICLES OF ORGANIZATION of THE BAZAIRE GROUP, LLC (Company) are amended as follows:

1. The name of the Company is THE BAZAIRE GROUP, LLC.
2. The Articles of Organization of the Company were filed with the Secretary of State of Florida on January 21, 2003.
3. Article 7 concerning profits and losses is deleted and the following is substituted therefor:

**ARTICLE VII  
PROFITS AND LOSSES**


(a) *Profit Sharing.* The members shall be entitled to the net profits arising from the operation of the limited liability company business that remain after the payment of the expenses of conducting the business of the limited liability company. Each member shall be entitled to a share of the profits in accordance with each members' ownership interest.. The distributive share of the profits shall be determined and may be paid to the members each year on the anniversary date of the commencement of business of the limited liability company, the month and day of the commencement date being January 21, 2004.

(b) *Losses.* All losses that occur in the operation of the limited liability company business shall be paid out of the capital of the limited liability company and the profits of the business, or, if these sources are insufficient to cover such losses, by the members in accordance with each members' ownership interest.

4. The Articles of Organization shall otherwise remain in full force and effect.
5. The foregoing amendment was adopted unanimously by the members without a meeting with the consent and approval of each of the members as signified by their signatures below.
