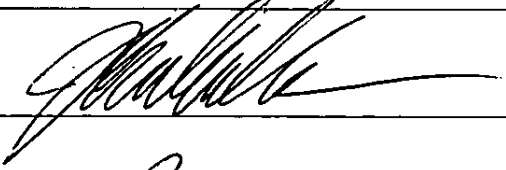

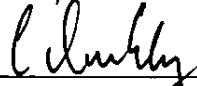
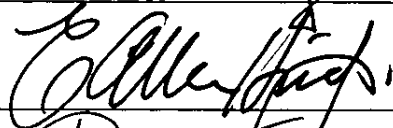
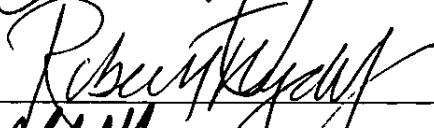

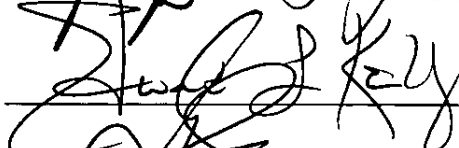

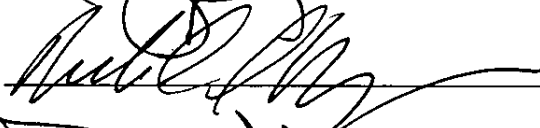
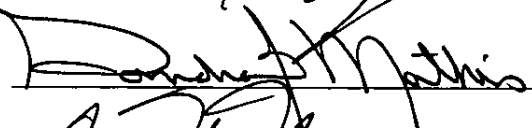
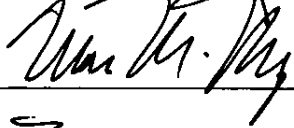
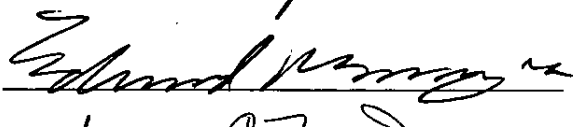
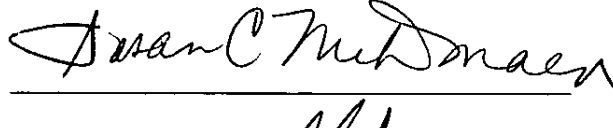
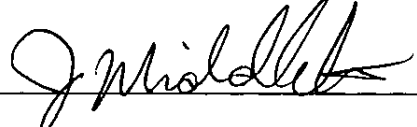
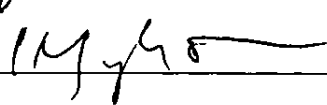
1. The name of a limited liability company is VENTURE PARTNERS, LLC.
