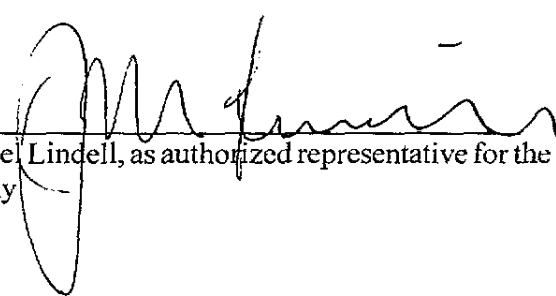
ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS
