



The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I
NAME

The name of this Limited Liability Company shall be ASSOCIATES LIMITED TITLE AGENCY, L.L.C. (hereinafter "L.L.C.").

ARTICLE II
ADDRESS


