# ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company and the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE 1 - NAME**

The name of the limited liability company shall be **WEBACCESSDESIGNS.COM**, **LLC**, ("Company").

### **ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 936 S.E. 20th Ct., Cape Coral, Florida 33990 and the mailing address shall be the same.
