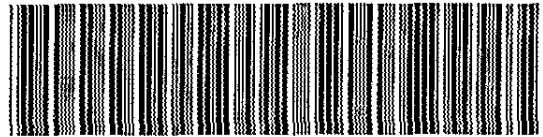

Pursuant to Section 608.407 of the Florida Statute**

**First:** The name of the limited liability company is: **DOLTEX GROUP LTD. CO.**

**Sixth:** The duration of the Limited Liability Company shall be perpetual.


