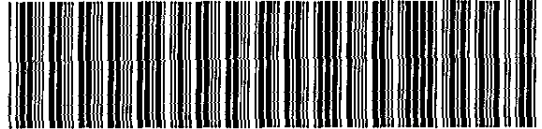

**ARTICLES OF ORGANIZATION**

**ARTICLE 1 - NAME**






