

ARTICLES OF ORGANIZATION

OF

GONZALEZ HOLDINGS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **GONZALEZ HOLDINGS**, **LLC**, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 6921 Dima Road, Tampa, Florida 33634 and the mailing address shall be the same.
