**ARTICLES OF ORGANIZATION  
FOR  
PUSH TO TALK, LLC**

**ARTICLE 1 – Name.** The name of the limited liability company shall be Push To Talk, LLC.

**ARTICLE 2 – Address of Principal Office.** The principal office of the limited liability company shall be 451 Eagle Ridge Drive, Lake Wales, Florida 32853.


**ARTICLE 3 – Mailing Address.** The mailing address of the limited liability company shall be 7558 Nolton Way, Orlando, Florida 32822.

**ARTICLE 4 – Registered Office and Registered Agent.** The name and the Florida street address of the initial registered agent is Jose Fernando Toro, 7558 Nolton Way, Orlando, Florida 32822.

**ARTICLE 5 – Management.** One or more managers shall manage the limited liability company. Therefore, it is a manager-managed company. Initially, Jose Fernando Toro shall serve as the manager of the limited liability company. The initial manager may receive a salary for such services and may serve as manager until his or her resignation or removal for cause as determined by a majority vote of the members. The operating agreement for the company may modify the number of managers for the company and their respective terms.

**ARTICLE 6 – Membership.** The company may issue certificates to indicate ownership in the company; with one percentage of ownership interest equating to one membership unit, for a total of 100 membership units. No change of membership in the company may occur without the unanimous consent of all then-existing members and the manager.
