ARTICLES OF ORGANIZATION OF LAW OFFICE OF D. ROSS BRIDGER, P.L.L.C.

The undersigned, for the purpose of forming a professional limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608 and the relevant portions of F.S. Chapter 621, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the professional limited liability company shall be LAW OFFICE OF D. ROSS BRIDGER, P.L.L.C. ("Company").

ARTICLE II - ADDRESS

ARTICLE V - EFFECTIVE DATE

The right, if given, of the remaining members of the limited liability company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued conditions of membership of a member in the limited liability company.
