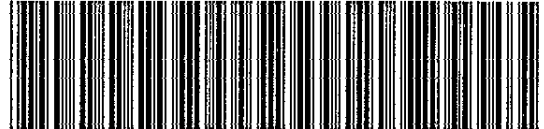

**ARTICLES OF AMENDMENT TO ARTICLES OF
ORGANIZATION OF SEABREEZE OFFICE ASSOCIATES, LLC**

The Articles of Organization of Seabreeze Office Associates, LLC, a Florida limited liability company (the "Company"), are amended as set forth in these Articles of Amendment:

1. The name of the Company is Seabreeze Office Associates, LLC.
2. The date of filing of the Company's Articles of Organization was January 24, 2003.
3. The purpose of these Articles of Amendment is to amend Article 6 of the Articles of Organization of Seabreeze Office Associates, LLC, to allow the Company to be managed by either members or non-member managers, by providing that the Company will be managed as provided in the Company's operating agreement
4. Article 6 of the Articles of Organization of the Company is hereby amended to read as follows:

**"ARTICLE 6
MANAGEMENT**

This limited liability company shall be managed by such managers as may be elected or appointed from time to time by the members pursuant to applicable provisions of the operating agreement of the company."

5. This amendment was adopted by the members of the Company on February 7, 2003, and the number of votes cast for the amendment by the members was sufficient for approval.
6. This amendment is made pursuant to Sections 608.411, Florida Statutes.
7. This amendment is effective immediately upon being filed with the Florida Department of State.
