**ARTICLES OF ORGANIZATION  
OF  
CORE LIDO, LLC**

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida, does set forth the following:

**ARTICLE I - NAME**

The name of the Company is **CORE LIDO, LLC.**

**ARTICLE II - DURATION**

The duration of the Company is perpetual.

**ARTICLE III - ADDRESS AND PLACE OF BUSINESS**

**ARTICLE IV - PURPOSE**

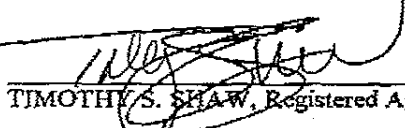
