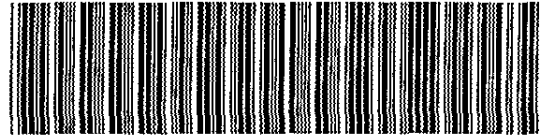


**ARTICLE IV -- REGISTERED OFFICE AND AGENT**


