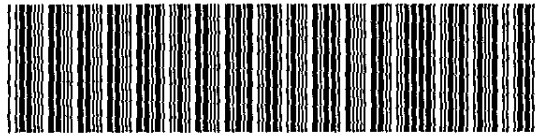

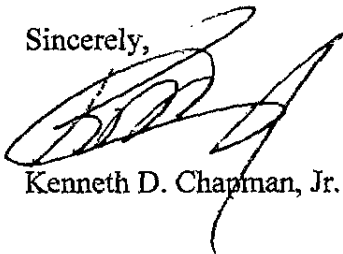

ARTICLE I

Name

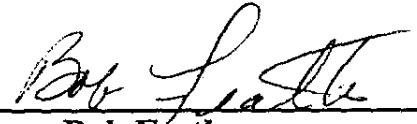
