## ARTICLES OF ORGANIZATION OF CHANCE, LLC

The undersigned, for the purpose of forming a limited liability company under the explorida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, arterile the following Articles of Organization.
