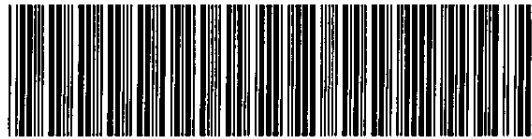

Global Sourcing International, LLC

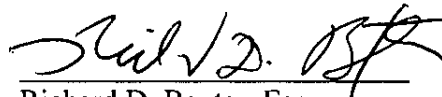
- B. Article IV of the Articles of Organization is hereby deleted in its entirety and is replaced by the following new Article IV:
