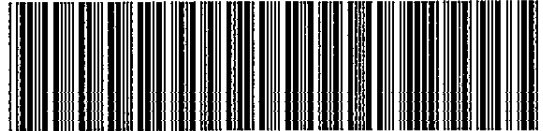

All members of the LLC have provided written consent for the dissolution of the LLC below pursuant to 608.441 (10 (c), Florida Statutes.

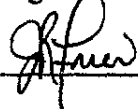
