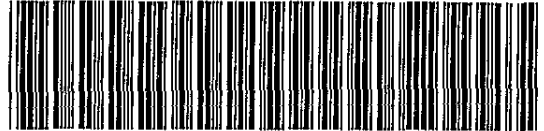



**ARTICLES OF ORGANIZATION  
OF  
MIGHTY FINE PINE, LLC**

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

**ARTICLE I**

**NAME**

The name of the Limited Liability Company is: Mighty Fine Pine, LLC.

**ARTICLE II**

**PRINCIPAL PLACE OF BUSINESS**

The principal place of business of the Limited Liability Company is: 477 Linkside Place, Destin, Florida, 32550. The mailing address of the Company is: 10859 Emerald Coast Parkway West, PMB 424, Destin, Florida 32550.

**ARTICLE III**

**REGISTERED OFFICE AND AGENT**

The address of the initial registered office of the Limited Liability Company is 4509 Furling Lane, Suite 210, Destin, Florida 32541. The name of the initial registered agent is Jeffrey M. Stephens.

**ARTICLE IV**

**MANAGEMENT**

The Limited Liability Company is to be managed by a manager or managers and is, therefore, a manager-managed Limited Liability Company. All documents executed on behalf of the Limited Liability Company need only be signed by one of the managers. All third parties may rely on documents executed by one of the managers as binding the Limited Liability Company. The initial manager of the Company may be replaced, and additional managers may be added by a vote of the members as more fully set forth in the operating agreement for the Limited Liability Company.

## ARTICLE V

### LIMITED LIABILITY

The members and managers of the Limited Liability Company shall have limited liability as provided for in the operating agreement and the applicable provisions of the Florida Limited Liability Act.

## ARTICLE VI

### INDEMNIFICATION

The Limited Liability Company shall indemnify the members and managers of the Limited Liability Company to fullest extent provided by law including, without limitation, the provisions of the operating agreement and the provisions of the Florida Limited Liability Act.

## ARTICLE VII

### DISSOLUTION

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member of the Limited Liability Company, the Limited Liability Company shall be terminated unless the remaining members unanimously agree to continue the business of the Limited Liability Company.

## ARTICLE VIII

### TRANSFER OF INTEREST

A member may transfer that member's right to receive shares of profits and returns of capital contributions, but may not assign any of the rights to participate in the management or to be a member of the Limited Liability Company unless prior written consent is obtained by the transferor from all the remaining members.


