The state of the s The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, pursuant to Chapter 608 of the Florida Statutes, hereb makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE I. NAME
