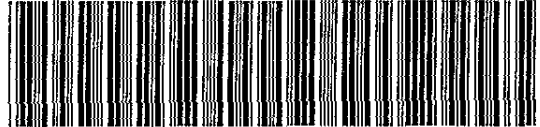

1. **ARTICLE I** be, and is hereby made to read as follows:

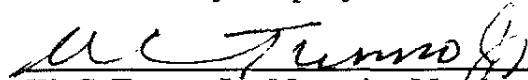
The name of the Limited Liability Company is **A & O GROVES, LLC**.
