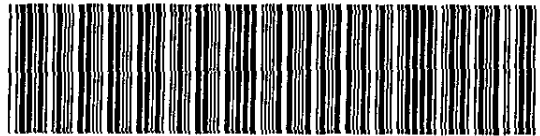



## ARTICLES OF ORGANIZATION

OF

DIRT YARD, L.L.C.


