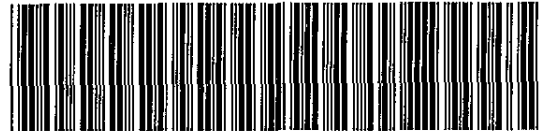

Article VIII - Limitation on Agency Authorized of Members




