ARTICLES OF ORGANIZATION

The undersigned, being members, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, do hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is **EXPORT OF AMERICA, LLC** (the "Company").

ARTICLE II. ADDRESS

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of State, and shall continue perpetually, unless terminated in accordance with the Company's Operating Agreement, or by the unanimous written agreement of all Members,

ARTICLE VI. PURPOSE

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.


ARTICLE VII. ADDITIONAL MEMBERS


ARTICLE VIII. OPERATING AGREEMENT

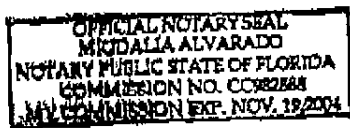
