**ARTICLE VI – Members's Rights to Continue Business**

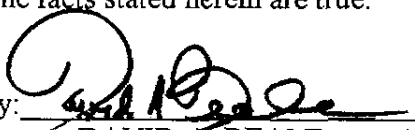

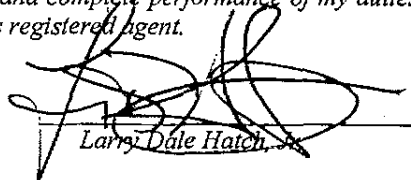
