The undersigned, pursuant to the provisions of Chapter 621 of the Florida Statutes for the purpose of forming a limited liability company, under the laws of the State of Florida, do hereby set forth the following:

ARTICLE I NAME

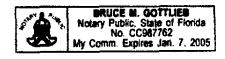
