**ARTICLE VII-CONTINUATION AFTER INVOLUNTARY TERMINATION**

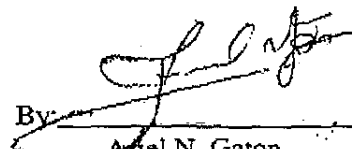

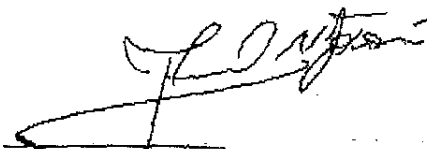
