The undersigned Organizer hereby submits these Amended & Restated Articles of Organization (these "Articles") to the Florida Department of State, Division of Corporations, pursuant to Sections 608.407, 608.408 and 608.4081, FLA. STAT. (2002), for the purpose of forming a limited liability company pursuant to the Florida Limited Liability Company Act (the "Company").

Article I NAME

The name of the Company shall be "Colts Neck Investor Group I, LLC."

Article II REGISTERED OFFICE & REGISTERED AGENT

The Company's initial registered office and principal place of business shall be located at 1499 West Palmetto Park Road, Suite 200, Boca Raton, Palm Beach County, Florida 33486-3321, and the name of its initial registered agent at such address shall be Steven M. Goldfarb. Article III Organization of Company

Stat. (2002).
