## ARTICLES OF ORGANIZATION FOR MSM HOLDINGS, L.L.C.

#### **ARTICLE I - NAME**

The name of the Limited Liability Company is MSM HOLDINGS, L.L.C

#### **ARTICLE IV - MEMBER UNITS**



#### ARTICLE VI - ADMISSION OF ADDITIONAL MEMBER

The members of the Limited Liability Company shall be permitted to admit additional members upon approval of members owning all the issued and outstanding Member Units of the Limited Liability Company. The Members of the Limited Liability Company shall have the right to withdraw as a member with (i) six (6) months prior notice, and (ii) with the unanimous consent of all the members.

#### ARTICLE IX - DISTRIBUTION

The purpose of the Limited Liability Company is to engage in one or more businesses and/or to invest and reinvest its assets. A coordingly, no distribution is contemplated. Notwithstanding the foregoing, the Board of Managers and all of the members may consent to a distribution.

#### **ARTICLE X - OFFICERS**

The managers shall hold those offices and have those responsibilities accorded to them by the members of the Limited Liability Company, as set forth in the Regulations of the Limited Liability Company.
