The Articles of Organization of Coral Bay Health Care Associates, LLC (the "Company") were filed on February 3, 2003. In accordance with Section 608.411, these Amended and Restated Articles of Organization of Coral Bay Health Care Associates, LLC have been duly executed and are being filed to amend and restate in their entirety all prior articles of organization filed on behalf of the Company. The Company's Amended and Restated Articles of Organization are as follows:

1. **Name.** The name of this limited liability company is CORAL BAY HEALTH CARE ASSOCIATES, LLC, a Florida limited liability company.
2. **Duration.** The Company shall have perpetual existence, commencing on February 3, 2003, the date of filing the Articles of Organization with the Florida Department of State, unless the Articles of Organization or the operating agreement of the Company provide otherwise.
