

**ARTICLES OF ORGANIZATION
OF**

THE LAW OFFICE OF THOMAS A. KENNEDY, P.L.

The undersigned, for the purpose of forming a professional limited liability company pursuant to the Florida Professional Service Corporation and Limited Liability Company Act, F.S. Chapters 608 and 621, hereby make, acknowledge, and file the following Articles of Organization establishing a Florida "Professional Limited Liability Company."

ARTICLE I -- NAME

The name of the professional limited liability company shall be The Law Office of Thomas A. Kennedy, P.L.

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company is 370 35th Court S.W. Vero Beach, FL 32968.

ARTICLE III -- DURATION

The company shall commence its existence on the filing date these articles of organization with the Florida Department of State. The company's existence shall be perpetual unless the company is dissolved earlier by unanimous written consent of all members as provided in these articles of organization or in any Operating Agreement of the company.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the state of Florida are Thomas A. Kennedy, 370 35th ct. S.W., Vero Beach, FL, 32968.

ARTICLE V -- CAPITAL CONTRIBUTIONS

The initial capital contribution of the members of the company shall be \$100.00 Dollars cash. Any capital contribution required of any additional members shall be determined by the unanimous consent of the existing members at that time.

ARTICLE VI -- ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company only on the unanimous written consent of all the members.

ARTICLE VII -- ADMISSION OF NEW MEMBERS

The Company's initial members names and addresses are as follows:

Except as set forth in these Articles or any Operating Agreement of the company, no additional members shall be admitted to the company except if they are an attorney licensed to practice law in the State of Florida, and with the unanimous written consent of all the then existing members of the company and on the written terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in these Articles and

any Operating Agreement of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all of the members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent and the proposed new member is otherwise authorized by Florida Law, the Florida Rules of Professional Conduct, and the rules Regulating the Florida Bar.

ARTICLE VIII -- MEMBERS' RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by a majority vote of the remaining members.

ARTICLE IX -- MANAGEMENT

The company shall be managed by a manager in accordance with any Operating Agreement of the company adopted by the members for the management of the business and affairs of the company. Any Operating Agreement of the company may contain any provisions for the regulation and management of the affairs of the company which are not inconsistent with law or these Articles of Organization. The name and address of the initial manager of the company is Thomas A. Kennedy, 370 35th Ct. S.W. Vero Beach, FL, 32968.

ARTICLE X -- SCOPE OF BUSINESS/REQUIREMENTS

The company shall engage in any business which is authorized by law and approved by the members of the company, pursuant to these Articles of organization, and any Operating Agreement of the company, and in any event all members shall engage in the practice of law. All members of the company must be attorneys licensed to practice law in the state of Florida.
