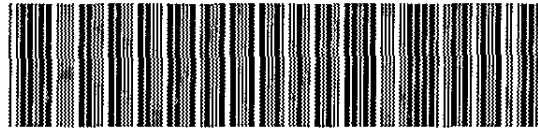

LIMITED POWER OF ATTORNEY




