**ARTICLES OF ORGANIZATION
FOR
TRAVEL EXPRESS INVESTMENT, LLC**

ARTICLE 1 – Name. The name of the limited liability company shall be Travel Express Investment, LLC.

ARTICLE 2 – Address of Principal Office. The mailing address and principal office of the limited liability company shall be 1113 North Pine Hills Road, Orlando, Florida 32808.


