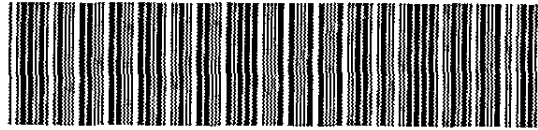

ARTICLES OF ORGANIZATION
OF
KARL A. BURGUNDER, ATTORNEY AT LAW, P.L.

The undersigned member, for the purpose of forming a professional limited liability company ("Company") under the Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization:

ARTICLE I - NAME

The name of this Company is: KARL A. BURGUNDER, ATTORNEY AT LAW, P.L.

ARTICLE II - PROFESSIONAL PURPOSE

The undersigned is a member in good standing of the Florida Bar. The professional purpose for which this Company is organized is the practice of law. Further, the Company shall have all powers and protections permitted to a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes and the Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes, which powers shall include, but in no way be limited to, the authority of the Company to invest its funds in real estate, mortgages, stocks, bonds, or any other type of investments, or to own real or personal property necessary for the rendering of professional services. 
