The Articles of Organization were initially filed by the Florida Secretary of State on February 6, 2003.

Amendment Adopted: The following Article has been added to the Articles of Organization, and the Articles of Organization are hereby amended:

"ARTICLE V

The Company is hereby authorized to issue 1,000,000 Class A Voting Membership Percentage Interest Units, which shall be designated as "Voting Units." The Company is also authorized to issue 1,000,000 Class B Non-Voting Membership Percentage Interest Units, which shall be designated as "Non-Voting Units."
