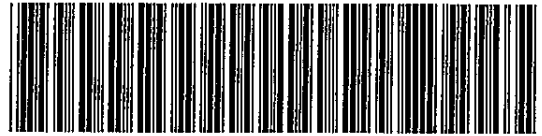


**ARTICLE V - ADMISSION OF NEW MEMBERS**
