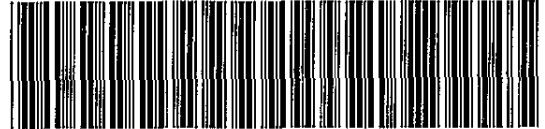

The company may admit any additional members upon the member becoming a party to the operating agreement.


#### **ARTICLE 10: AMENDMENT**




