ARTICLES OF ORGANIZATION  
OF

The undersigned, acting as the organizer of BENDERS AUTO BODY, LLC under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

**ARTICLE I**

**NAME**

The name of the limited liability company is BENDERS AUTO BODY, LLC (the "Company").

**ARTICLE II**

**ADDRESS**

**EFFECTIVE DATE; DURATION**

## ARTICLE VI

### ADOPTION OF OPERATING AGREEMENT

The Company shall adopt an Operating Agreement for the Company, which Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with these Articles of Organization or Chapter 608, Fla. Stat.

## ARTICLE VII

### INITIAL REGISTERED AGENT AND OFFICE

The initial registered agent for the Company shall be Daniel Johnson, and the street address of the Company's initial registered office is 515 Kerry Drive, Orlando, Florida 32808.

## ARTICLE VIII

### AMENDMENTS

The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated by the unanimous written approval of all Members of the Company.

## ARTICLE IX

### INDEMNIFICATION

Each individual or entity who is or was a Member of the Company (and the heirs, executor, personal representatives, administrators, successors or assigns of such individual or entity) who was or is made a party to, or is involved in any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative, by reason of the fact that such person is or was a Member of the Company ("Indemnitee"), shall be indemnified and held harmless by the Company to the fullest extent permitted by applicable law, as the same exists or may hereafter be amended. In addition to the indemnification conferred in this Article, the Indemnitee shall also be entitled to have paid directly by the Company the expenses reasonably incurred in defending any such proceeding against such Indemnitee in advance of its final disposition, to the fullest extent authorized by applicable law, as the same

Any repeal or amendment of this Article by the Members of the Company shall not adversely affect any right or protection of a member or officer existing at the time of such repeal or amendment.

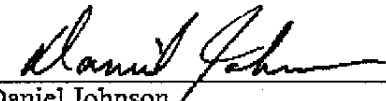
#### ARTICLE X

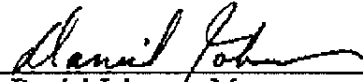
