ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION
CRYSTAL MOTOR CAR COMPANY OF HERNANDO, LLC

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, the Articles of Organization of Crystal Motor Car Company of Hernando, LLC, a Florida limited liability company (the "Company"), are hereby amended as follows:

1. The name of the company is Crystal Motor Car Company of Hernando, LLC.
2. The Articles of Organization of the Company were filed on February 7, 2003, and assigned document number 1.03000004782.
3. The Articles of Organization of the Company are hereby amended to add a new Article IV to read in its entirety as follows:

"ARTICLE IV

The interests of the Company are securities represented by certificates in registered form governed by Article 8 of the Florida Uniform Commercial Code and shall be treated as securities for all purposes under the Florida Uniform Commercial Code."
