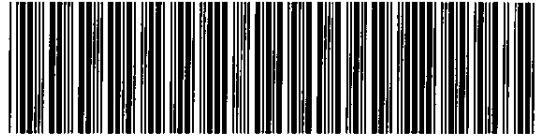

**ARTICLE I. NAME**

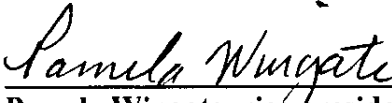
The name of this limited liability company shall be Booyah Enterprises, LLC.
