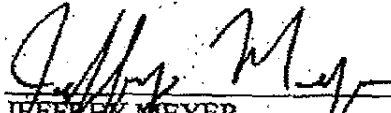
ARTICLE V

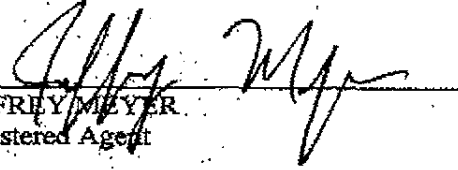
