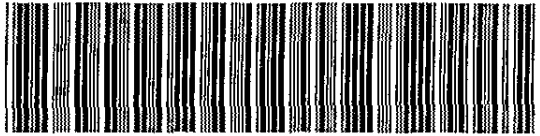

**ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION
OF
LANDSTAR BUILDERS, LLC**

Pursuant to the provisions of Florida law, the undersigned Limited Liability Company adopts the following Articles of Amendment to its Articles of Organization:

1. The name of the Limited Liability Company is **LANDSTAR BUILDERS, LLC**.

2. The following Amendment of the Articles of Organization was adopted by the Members of the Limited Liability Company on the 24th day of September, 2003, in the manner prescribed by Florida law.
