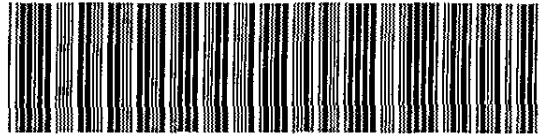


Article I of the Articles of Organization filed on February 10, 2003 is amended as follows:
