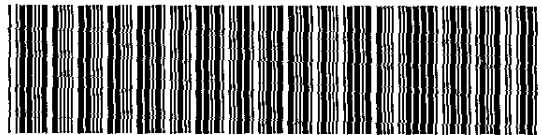

ARTICLE I
NAME
