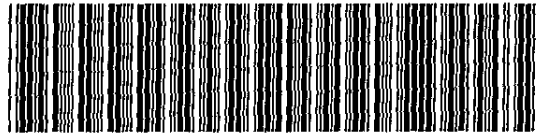



ARTICLES OF ORGANIZATION
OF

The undersigned, James J. Taylor Jr., who is the authorized representative of the below-identified limited liability company, and of the sole member thereof, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I -- NAME


ARTICLE V -- COMPANY TO BE MANAGED BY MEMBER(S)


