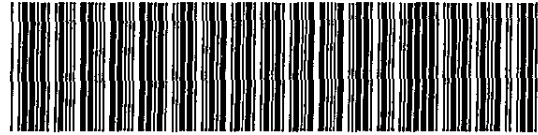




ARTICLE VI - PURPOSE
