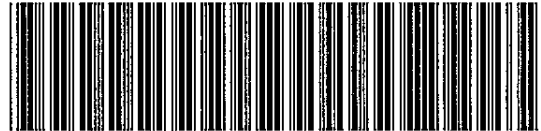

ARTICLE 4. MANAGEMENT RESERVED TO ONLY NAMED MEMBER
