## ARTICLES OF ORGANIZATION OF N B FINANCIAL, LLC

- 1. Name. The name of this Limited Liability Company is N B FINANCIAL LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of Florida Statutes.
