

## ARTICLES OF ORGANIZATION OF

### FIDELITY FIRST TITLE OF PINELLAS, LLC,

a Florida Limited Liability Company

#### ARTICLE I NAME

The Name of this Limited Liability Company is FIDELITY FIRST TITLE OF PINELLAS, LLC (The "Company").

## ARTICLE II ADDRESS
