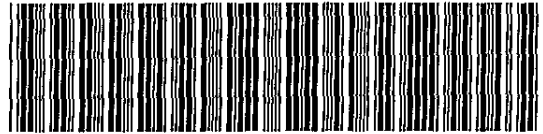




FIRST: The effective date of the articles of organization for Maple Leaf Electric, L.L.C. was February 7, 2003 and the filing date was February 12, 2003.
